## NOTICE OF BUDGET WORKSHOP AND REGULAR MEETING OF THE BOARD OF DIRECTORS

The Board may consider any item on this agenda in any order and at any time during the meeting. The Governing Board may convene into Executive Session for discussion or consultation for legal advice with its attorney regarding any item on this agenda, in accordance with A.R.S. §38-431.03(A)(3).

In order to observe social distancing for the safety of our community, this meeting will be conducted <u>remotely only</u>. There will be no in-person meeting for members of the public. The Arizona Open Meeting Law permits a public body to hold a remote meeting through technological means.
