The Tubac Fire District Board of Directors will meet in regular session on May 25, 2022, at 1:30 p.m. at Tubac Fire Station #2, 1360 W. Frontage Rd., Rio Rico, AZ 85648. The following topics and any matters related thereto, will be subject to Board consideration, discussion, approval, or other action. The Board may consider any item on this agenda in any order and at any time during the meeting. The Governing Board may convene into Executive Session for discussion or consultation for legal advice with its attorney regarding any item on this agenda, in accordance with A.R.S. §38-431.03(A)(3).

The Fire Board Chair may adjust time limitations and all individuals desiring to address the Fire Board will have the same opportunity."
