### **Board Action Request**

SUBJECT: Tubac Fire Station 1 Conceptual Drawing

DATE: June 19, 2023

**Background:** Tubac Fire staff and WSM completed a needs assessment in 2020 and it was determined that the best course of action was the replacement of our station 1. Based on the needs assessment WSM completed a conceptual drawing. The original drawing has been modified several times into what is being presented today. The proposed concept has a total building area of 8,992 sq. ft., this has been modified from its original 12,400 sq. ft. design.

After many discussions the fire station was downsized as per board members 'direction. Several modifications were made to include the removal of non-essential rooms and offices, and removal of hallways to decrease unusable space.

The building is broken down into two spaces: the administrative space and the fire station. The proposed concept has a 1,649 sq. ft. administrative space, and a fire station space of 7,343 sq. ft. that includes the apparatus and equipment bay. The total building area is below the square footage area of 9,000.

Once the conceptual drawing has been approved, we will be able to move forward with the USDA Rural Development application and submit our preliminary architectural feasibility report and the phase I environmental report. The board has seen both the draft feasibility and phase I reports and they are currently awaiting modifications based on the updated concept.


**Fiscal Impact:** \$4,795,703.363 based on a projected \$533.33 per sq. ft. as per WSM's most recent project.




# CONCEPTUAL SITE PLAN
